**MUNICIPAL PARK GRANT COMMISSION**

**GRANT AGREEMENT – AMENDMENT # 2**

This Amendment #2 is entered into this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and between the Municipal Park Grant Commission, hereinafter referred to as “Commission” and the Cities of Fenton, Kirkwood and Sunset Hills, Missouri, hereinafter referred to as “Grantee” and amends certain provisions of the Grant Agreement entered into between Commission and Grantee on June 1, 2018.

*Whereas*, the Grant Agreement allocates certain grant funds to specific elements of the overall project; and

*Whereas*, the Grant Agreement has allocated \$1,300,870 for the construction of pedestrian bridge landing sites on the I-44 bridge over the Meramec River in conjunction with MODOT's reconstruction of the highway bridge; and

*Whereas*, engineering estimates have removed many of the amenities originally proposed for the project but the cost of the project has increased to \$1,725,000; and

*Whereas*, MODOT requires payment for cooperative projects prior to the letting of bids, which the City of Sunset Hills has agreed to do; and

*Whereas*, Grantee has made the requisite showing to the Commission that the typical reimbursement procedure would create a hardship and the City of Sunset Hills has requested reimbursement of of \$1,300,870 which has been paid to MODOT; and

*Whereas*, the Commission approved such amendments to the project scope, including costs increases and the payments to the Grantee for reimbursement of payments to MODOT prior to completion of the project; and

*Whereas*, the Commission will approve reimbursement for the final project costs to the City of Sunset Hills at a future meeting;

THEREFORE:

I. Exhibit A, attached to the Grant Agreement and referenced in Section 1 thereof is replaced with Exhibit A attached hereto.

II. The parties hereby agree that, except as provided herein, all other provisions of the Agreement, including the total amount of the grant are unchanged and shall remain in full force and effect.
