APPROVAL OF THE MINUTES

Copies of the Minutes of the June, 2021 Pool Advisory meeting were distributed to the members for their review. Mayor Fribis made a motion to accept the minutes as submitted. Ms. Duke seconded the motion, and it was unanimously approved.

Old Business

Ms. Hoffmann asked if Ms. Ortman would like to speak, Ms. Ortman asked if Riverwalk could be open 5:30 -7pm Mon – Thurs until Labor Day Weekend and if we could offer River walk the week after Labor Day 5:30 -7pm until Sept. 10th.

Mr. Brown reported that if we have the guards, this request should be no problem to cover. The Committee requested that Mr. Brown check and see if we have the guards to cover the request.

New Business

A. Discussion on Pool Operations

Mr. Brown reported that Aquatic Facility operated ok under the circumstances. We were very short on guards this year which was a challenge, Here is a forecast for the finances at this time, Mr. Brown will provide a detailed report in September.

Revenue – \$191,000

Operating – \$206,000

Capital – \$60,000

Reminder, we did not open the facility to daily entries, which typically brings in \$70,000 - \$85,000 annually.

The pool starts reduced hours today, 4- 7pm lap pool Monday – Friday, 12-7 Saturday/Sunday – all facilities.
