- \_\_\_ (A) - RESTAURANT BAR I/We certify that the restaurant being operated by me/us on the premises produces from the sale of prepared meals or food consumed on the premises at least fifty percent (50%) of the gross income of the business or has an annual gross income of at least \$200,000 from the sale of prepared meals or food consumed on such premises, in accordance with Section 801.084. SLCRO. This license does allow package liquor sales on Sunday. Hours of operation are from 9:00 A.M. to 12:00 midnight.**
- \_\_\_ (B) - AMUSEMENT PLACE I/We certify that the establishment for which I/we make application for a license has at least six thousand (6,000) square feet where games of skill commonly known as bowling, soccer, billiards, volleyball, indoor golf or outdoor golf (minimum of nine holes) are played and which has an annual gross receipt of at least \$100,000 which at least \$50,000 of which must be in non-alcoholic sales in accordance with Section 801.085. SLCRO. This license does allow package liquor sales on Sundays. Hours of operation are from 9:00 A.M. to 12:00 midnight.**
- \_\_\_ (C) – TAX EXEMPT ORGANIZATION I/we certify that the establishment for which I/we make application for a license is a charitable, fraternal, religious, service or veteran’s organization which has obtained an exemption from payment of Federal Income Taxes as provided in Section 501( c ) (3), 501 ( c )(4), 501 (c) (5), 501 ( c ) (8), 501 ( c ) (10), 501 ( c ) (19), or 501(d) of the United States Internal Revenue Code 1954 as amended, in accordance with Section 801.086.
